- Goods purchased for ₹ 5,000 were posted as ₹ 500 to the purchases account.
- $\quad$ Credit purchase of ₹ 1,040 from Rishi was passed in the books as ₹ 1,400.
- Goods (cost ₹ 5,000 , sales price ₹ 6,000 ) distributed as free samples among prospective customers were not recorded anywhere.
- Goods worth ₹ 1,500 returned by Green \& Co have not been recorded anywhere

Q2.A Book-keeper finds the difference in the Trial Balance amounting to ₹ 210 and puts it in the suspense account. Later on he detects the following errors. Rectify these and prepare the Suspense Account:-

- Goods purchased from Roshan ₹ 700 was passed through sales book.
- Returned goods to Shivank ₹ 1,500 was passed through returns inward book.
- An Item of ₹ 450 relating to prepaid rent account was omitted to be brought forward.
- An Item of ₹ 120 in respect of purchase returns, instead of being recorded in Returns outward book has been wrongly entered in the purchase book and posted therefrom to the debit of Personal A/c.
- Amount payable to Sahil for repairs done to radio ₹ 180 and a new radio supplied for ₹ 1,920 , were entered in the Purchase book as ₹ 2,000 .

- A bill for ₹ 10,000 was retired by the Bank under a rebate of $₹ 200$ but the full amount of the bill was credited in the bank column of the Cash Book.
